CREDIT TERMS

1. Credit is being advanced based on the credit worthiness of the Corporation and of the Principal Shareholder. The Corporation and the Principal Shareholder shall be jointly and severally responsible for repayment of all credit advances.
2. All accounts are due and payable on or before the 15th of the month following the date of purchase.
3. Interest will be charged on overdue accounts at the rate of 1.5% per month (19.56% per annum) calculated and compounded monthly, daily from the time it first accrues until payment is made (notwithstanding any Judgment or attachment or other process of the law taken against the Credit Applicants in respect to such invoice of account).
4. The Credit Applicants shall be responsible for the full amount of all proper and reasonable costs, expenses, and fees incurred by Enercon to effect collection of overdue accounts on a solicitor and own client basis and such amounts shall become principal amounts owing on the account and shall be treated as such with respect to accrual of interest.
5. Payments shall apply firstly against the interest and other charges owing and then to the balance.
6. In the event the account becomes overdue, all accounts including current invoices, shall, at Enercon's option, become due and payable immediately. The Credit Applicants authorize Enercon to charge the balance of the account to the Credit Applicants' credit card as provided above.
7. No goods are returnable without the proper authorization from Enercon. Authorized returns are subject to a 20% restocking charge.
8. The Credit Applicants consent to Enercon obtaining credit information on the Credit Applicants, including the obtaining of a Credit Report from any third party. The Credit Applicants consent to any third party releasing the Credit Applicants' credit information to Enercon.
9. The Credit Applicants consent to Enercon releasing to credit agencies or building suppliers the Credit Applicants' credit information.
10. If approved, the actual credit granted may be less than the amount specified in the Application.
